

## GINZA SIX Reward Point Policy

### Article 1. Purpose

This Policy provides the details and terms and conditions for the privileges (hereinafter the “Reward Point Program”) in which GINZA SIX Retail Management Co., Ltd. (hereinafter the “Company”) provides the reward point members defined in the following article with the GINZA SIX reward points (hereinafter the “Reward Points”).

### Article 2. Reward Point Members

1. The term “reward point member” refers to a person who is a member of either the card or the app defined in the following items.  
(1) The term “Card Member” or “Card Members” refers to a member or members of the GINZA SIX card (hereinafter the “Card”) issued by Mitsubishi UFJ NICOS Co., Ltd. (hereinafter “Mitsubishi UFJ NICOS”) based on the partnership between the Company and Mitsubishi UFJ NICOS.  
(2) The term “App Member” or “App Members” refers to those who have completed the prescribed registration process on the GINZA SIX App (hereinafter the “App”) specified in the GINZA SIX App Terms of Use.  
2. If a reward point member loses their membership as the Card Member or the App Member (only when the member no longer falls within both items in the preceding paragraph), the member shall immediately lose their reward point membership. Additionally, if a reward point member violates this Policy, the Company may terminate the member’s reward point membership.

### Article 3. Granting of Reward Points

1. The Company grants Reward Points to the reward point members based on the following Article or Article 5.  
2. The balance of Reward Points on the Card and the App are calculated separately, and in principle they cannot be combined with the Reward Points granted to other Cards or Apps. However, if members have both the Card and the App and if their registration information is the same, their points may be combined within the app.

### Article 4. Presentation of the Card or the App

1. Reward Points will be granted to reward point members if they present the App before checkout or present and pay by the Card when they shop at stores specified by the Company.  
2. The granting of Reward Points based on the preceding paragraph is performed only if members present the App before checkout or use or if members present and pay by the Card. Reward Points will not be granted after checkout.  
3. In principle, the amount of Reward Points granted based on paragraph 1 is 1 point for every 100 yen (excluding tax) spent.  
4. Reward Points will not be granted to purchases less than 100 yen (excluding tax).  
5. Notwithstanding paragraph 1, the Company may deem charges for certain products, services, etc. and purchases at certain stores as ineligible for the granting of Reward Points.

### Article 5. Special Provisions on Granting of Reward Points to Card Members

1. Separately from the granting of Reward Points based on the preceding Article, the Card Members earn Reward Points by purchasing products or rights and receiving services using the Card (hereinafter the “Credit Card Payment”) and based on the amount of the Credit Card Payment (hereinafter the “Credit Card Payment Amount”).  
2. The amount of Reward Points to be granted based on the preceding paragraph will be determined by prescribed conditions and calculation method for each period, which will be closed by the Company’s prescribed method, and based on the ratios specified in each of the following items.  
(1) For every Credit Card Payment Amount of 100 yen (excluding tax) at GINZA SIX stores:  
- Prestige Card Members earn 2 credit card points  
- Gold Card Members earn 1 credit card point  
(Additionally, the Reward Points based on Article 3 will be granted.)  
Reward Points will not be granted to Credit Card Payment Amounts less than 100 yen (excluding tax).  
(2) For every Credit Card Payment Amount of 100 yen (including tax) at stores other than those specified in the preceding item:  
- Prestige Card Members earn 1 credit card point  
- Gold Card Members earn 1 credit card point  
Reward Points will not be granted to Credit Card Payment Amounts less than 100 yen (including tax).  
3. Notwithstanding paragraph 1, the payment amount listed in the items of paragraph 3 of the preceding Article as well as the payment amount listed in each of the following items shall be excluded from the scope of the Credit Card Payment Amount which is subject to the granting of Reward Points.  
(1) Annual fee for the Card  
(2) Fees, membership fees, etc. for the services provided by the Company or Mitsubishi UFJ NICOS  
(3) Fees for reissuance of the Card or for other services  
(4) Payment amount of and fee for credit card cash advance  
(5) Fees for revolving payments and installment payments  
(6) Additionally, the Company may deem the amount of certain credit card payments or the amount of credit card payments at certain member stores as ineligible for the granting of Reward Points.

### Article 6. Cancellation of Reward Points

In the event that the amount of payment is cancelled in whole or in part, including but not limited to, in the event that a purchase or a Credit Card Payment eligible for granting of Reward Points is cancelled, the Reward Points for such cancelled amount shall be cancelled based on each of the following items or the Company’s other prescribed methods.  
(1) Cancellation of Reward Points granted for a purchase due to returning of a purchased product is performed based on the receipt issued at the time of transaction and by deducting points from the reward point balance.  
(2) If a member has already used the Reward Points which became invalid, the member will be required to refund the amount based on the Company’s prescribed method (conversion rate: 1 point = 1 yen).

### Article 7. Use of Reward Points

1. Reward Points can be used only at GINZA SIX (conversion rate: 1 point = 1 yen) if the balance is 1,000 or higher. Reward Points cannot be used if the balance is less than 1,000.  
2. Reward Points used will be deducted automatically.  
3. Reward point balance and other information can be checked on the receipt issued at the time of purchase or on the App (available only to App Members).  
4. In no event can Reward Points be assigned or cashed.

### Article 8. Provision of Membership Privileges

1. Reward point members can receive prescribed membership privileges (event invitations, gifts, etc.) provided by the Company in exchange for Reward Points. Details of the membership privileges will be provided on the Company’s prescribed website or via the App.  
2. The Company may add, change, or end membership privileges at any time by updating the Company’s prescribed website or the App, and members shall acknowledge it in advance.  
3. Members are required to present the Card or the App as needed when they use membership privileges, and the Company may refuse to provide privileges if the Card or the App cannot be confirmed.  
4. If taxes and dues are imposed on membership privileges provided through the Reward Point Program, the reward point members shall be responsible for such taxes and dues.

### Article 9. Expiration of Reward Points

Taking the period from March 1st through the end of the following February as one fiscal year every year, Reward Points granted within a fiscal year will automatically become invalid at the end of February of the following fiscal year of the payment transaction date.

### Article 10. Loss, Theft, and/or Breakage of the Card

On the premise that reward point members will assume the obligation for managing the Card and/or the App with the due care of a good manager, the Company does not accept any liability for the damages to the reward point members or any other third parties due to loss, theft, breakage, etc. of the Card or the App.

### Article 11. Nullification of Rights

Reward point members shall have no objection to the fact that, if a reward point member loses their membership, whatever the reason may be, the entirety of valid Reward Points which have been accumulated will automatically become invalid and all rights under this Policy will be automatically nullified.

### Article 12. Prohibition of Assignment of Rights

For any reason whatsoever, reward point members may not lend or assign the rights or obligations under the Reward Point Program to others, provide such rights or obligations to others as collateral, or have others inherit such rights or obligations.

### Article 13. Outsourcing of Clerical Work

Reward point members shall acknowledge that the Company may outsource, in whole or in part, the clerical work involved with the calculation, accumulation, announcement, etc. of Reward Points to its affiliate companies.

### Article 14. Questions Regarding the Reward Point Program

With regard to questions arising in relation to the granting of Reward Points, validity of Reward Points, membership privileges, membership of reward point members, and other matters regarding the Reward Point Program, the Company shall make decisions and reward point members shall follow the decisions.

### Article 15. Termination, Discontinuation, Changing, etc. of the Reward Point Program

1. The Company may, without prior notice, discontinue the Reward Point Program in whole or in part or may make changes to the content.  
2. The Company may, without prior notice, change the number of Reward Points for the calculation of Reward Points specified in Article 4 and Article 5.  
3. The Company will not accept any liability for the damages caused to reward point members due to the preceding two paragraphs.  
4. The content of the Reward Point Program may be regulated under Japanese laws and regulations.

### Article 16. Addition, Change, Abolishment, etc. of This Policy

1. Additions, changes, and abolishment may be made to this Policy without prior consent of the reward point members.  
2. If any addition, change, and/or abolishment is made to this Policy, it will be notified or announced by the Company’s prescribed method. The same shall apply in the event that information such as the Company’s address and/or contact information has been changed.  
3. With the notification or announcement based on the preceding paragraph, it will be deemed that all reward point members have acknowledged the fact.  
4. In the event of unavoidable circumstances such as natural disasters or other emergency situations, the Reward Point Program may be temporarily stopped in whole or in part without a prior notification to reward point members.

### Article 17. Court with Jurisdiction

With regard to any dispute arising out of this Policy and the Reward Points, the Tokyo District Court shall be the court with exclusive jurisdiction over the first instance.
